



# A Look at CASA from All Points of View

Jodi Gault has experienced CASA from all points of view, having held various positions in the program since learning about CASA through a friend years ago.

Jodi, a former pediatric oncology nurse, moved to Colorado with her family eight years ago. She learned about CASA at a neighborhood gathering. She trained with our second class of volunteers, was appointed to her first case shortly thereafter and, lucky for us, CASA has been a part of her life ever since!

Before making the move to her current job, Jodi was a valuable member of our staff. She's been a case coordinator, program manager and training coordinator – all while volunteering as a CASA herself. Jodi's own current case as a volunteer will be wrapping up soon - she was appointed to it three years ago.

Jodi explained that whether it's taking kids for an ice cream, to a sporting event or finding ways to help their families get new school supplies – the CASA works to keep the children lives as normal as possible. "I'm amazed by the resiliency of these children who have been through so much," Jodi said, "and by how much it's really the little things that a CASA does that can really make a difference".

Jodi tells us, "I've met the most amazing people through CASA. They give so much of themselves for these kids. I also feel very fortunate to have had so many opportunities through CASA. I've seen firsthand the difference a CASA can make when it comes to an extra set of eyes helping to make sure these children get the services they need".

What has she learned from being involved with CASA? Jodi says the world is not nearly as black and white as she once assumed and that simply listening and being as open minded as possible is the best thing for these kids.

The common thread running through all of Jodi's roles in our program has been helping children in bad situations get the services they need and working to bring a sense of normalcy to their lives. It is something Jodi has done with unqualified commitment and extraordinary heart – our hats are off to her.

Jodi currently works as an assistant to a guardian ad *litem* (GAL) attorney. GALs are appointed to serve as the legal representative of children in protective custody, as required by the Colorado Children's Code. Jodi does intensive research and spends hours oneon-one with the children involved in Dependency and Neglect cases. Her goal is to arm the GAL with the best, most relevant information possible about the children they represent.

# A Letter from the Executive Director

As we make the annual transition from summer to fall, I am struck by the incredible increase in the pace at the CASA office. During the summer months, new case filings decrease (often times because children are not in school and school personnel are not seeing the signs of abuse and neglect), we assign fewer volunteers to cases because folks are busy with their own families and activities and we're not in the middle of training (but we hope to be next summer!). Once school is back in session though, everything changes! It becomes a very busy time for CASA Jeffco/ Gilpin.

September 2<sup>nd</sup> marked the beginning of our 17<sup>th</sup> CASA Volunteer Training. We are seeing the positive results of hiring a full time recruitment and training coordinator. Melissa Hellmuth has been on staff since April and the number of trainees in the September training class is double that of the previous class. We have several people already waiting for the training in February 2009. Our announcements are in many community publications, as well as in *YourHub* (an insert in the dailies every week). We have had a significant increase in the number of requests for speaking engagements and media interviews. Once people hear our mission and the work our volunteers do, they feel compelled to get involved.

We are also working hard to get ready for *The Magical Mile.* On October 25<sup>th</sup>, the Belmar Event Center will be transformed into the magical Land of Oz. The evening will include a silent and live auction, a terrific meal and the opportunity for us to come together and raise the money necessary to increase the number of children we can serve. Please make plans to join us for our annual gala/fundraiser.

On October 1<sup>st</sup>, we will submit our Quality Assurance Assessment to National CASA. This is a process the National CASA Association instituted five years ago to ensure that its more than 900 member organizations are delivering high-quality advocacy and operating strong programs. Every program across the country is required to complete the assessment every four years. The assessment instrument is very comprehensive and necessitates our being in compliance with the *Standards for Local CASA Programs* and the inclusion of nearly 60 *Indicators of Compliance.* The assessment will culminate three months of work by a committee comprised of staff, volunteers and board members. It is a lengthy and arduous process, however it is an opportunity to identify our program's strengths, challenges and needs to promote growth and sustainability. I have every confidence that CASA Jeffco/Gilpin will receive the highest marks possible when National CASA issues their report.

As hectic as things may be, not a day goes by that I don't pause and reflect on how fortunate CASA Jeffco/Gilpin is. Our volunteers are extraordinary people, making an extraordinary contribution on behalf of the children they serve. Our donors are extremely generous. And we continue to have strong support both within the "system" and in the greater community. Thank you all for being a part of CASA Jeffco/Gilpin.



# Collecting for a Cause

Last February, attorney and CASA volunteer Laura Locke came to us as she prepared to make a visit to South Korea. She was making the trip as part of a volunteer service group sponsored by the agency through which she adopted her own children.

Laura's goal was to collect 1,000 toothbrushes for children living in orphanages and rehabilitation centers in South Korea. Laura generously donated \$.50 to CASA for each toothbrush collected. CASA was pleased to see the toothbrushes roll in to help both our CASA children, as well as the children in South Korea.

In July, National CASA and The Office Depot Foundation teamed up to provide backpacks for children in need. CASA of Jefferson and Gilpin Counties received almost 700 hundred backpacks to distribute. With the help of our volunteers, we delivered backpacks to many children involved in the court system. Additionally, we gave 200 backpacks to Jeffco Action Center and 250 to Packs of Hope. Packs of Hope fills each backpack with one full set of clothes for children who weren't able to take anything with them when they were removed from their homes.

Due to the success of these collection events, we look forward to holding a quarterly drive to continually help our children meet some of their very basic needs.

# CASAs Provide Valuable Information for Child Protection Caseworkers

Asya Muhammad works for Jefferson County Human Services. She had been a caseworker until her recent promotion to placement coordinator. Asya sees first hand the difference having a skilled CASA involved in cases can make.

Human Services investigates allegations of child abuse and neglect. They provide protective services to children and youth who are at-risk and/or are victims of child abuse or neglect. It is their goal to preserve and strengthen the

family so the child can be returned home as soon as possible.

Asya sees CASA volunteers as valuable third parties who keep an eye out for children involved in Dependency and Neglect cases in Jefferson and Gilpin Counties. "CASAs are a good source of information and having a CASA on a case can prove very helpful," she said.

Asya explained that often times CASA volunteers find out information before case workers or guardian ad *litem* attorneys be-

cause of their relationships and good rapport with the children involved. She also explained that the programs CASA organizes for the children, like school supply giveaways, holiday gift collections, free tickets to ball games, etc., provide these children with items and opportunities they wouldn't otherwise have given their current situations.
