# A Letter from the Executive **Director and Board Chair**

Greetings from CASA Jeffco/ Gilpin! A new year brings renewed commitment on the part of the CASA board, our veteran volunteers and staff to the important work we do everyday for kids. It also provides an opportunity for new people to get involved. I am proud to announce that we are currently training 36 new volunteers! It is a time for us to reflect on our accomplishments in the previous year and to face the realities of the challenges we must overcome in the coming year.

We have included our 2007-2008 Annual Report for your review. In addition to this report, we'd like to provide some program highlights. CASA Jeffco/Gilpin began serving children eight years ago. That first year, we trained 23 volunteers who were assigned to 52 children. As of March 2009, we will have over 160 volunteers on our roster. Since the program began, our volunteers have

provided advocacy to over 700 children. Over the past eight years we have found that our extraordinary volunteers stay with our program an average of 2 1/2 years and that more than half of them are employed full time.


We are making great progress toward increasing the numbers of children for whom we are able to provide services. However, there is still much work to do. In 2008, Jefferson and Gilpin Counties ranked fourth in the number of abuse and neglect filings in the State. We are bracing for increased filings in 2009 due to the current economic crisis, knowing that families who are already experiencing tough times are pushed to the brink by the loss of a job or housing. Children are most vulnerable when their parents are in crisis. There is a sense of urgency as we try to recruit and train as many new volunteers as possible



As a Guardian Ad Litem (GAL), Doris Waters, a local attorney and resident of Jefferson County, finds the objective opinion and extra set of eyes that CASAs bring to the table invaluable.

Doris explained that CASAs help her with her cases, many times going far beyond expectations or requirements.

"Each party involved in an abuse or neglect case has considerations and concerns specific to their role, but the CASA's only concern is for the child, making them a completely objective advocate for the child," Doris explained.

"Because they really get to know the kids and what they are all about, they are able to determine their needs and really make a difference in their lives," Doris explained.

Doris described one case in particular where a female CASA has become a mentor of sorts to a little girl with a deceased mother. As the only consistent female in her life, her CASA


